Children aged 5-9 will be performing "**Hansel and Gretel, The Musical!**"

Children aged 10-17 will be performing "**Legally Blonde Jr.!**"

Legally Blonde JR. follows the transformation of Elle Woods as she tackles stereotypes, snobbery and scandal in pursuit of her dreams. When Elle's boyfriend, Warner, dumps her and heads to Harvard, claiming she's not "serious" enough, Elle takes matters into her own hands, crafting a showy song-and-dance personal essay and charming her way into law school. Befriending classmate, Emmett, and spunky hairdresser, Paulette, along the way, Elle finds that books and looks aren't mutually exclusive. As Elle begins outsmarting her peers, she realizes that law may be her natural calling after all.

Auditions:

To ensure a great start to our Spring Musical, we will be holding Auditions on the following days and times before the first night of rehearsal on Monday May 2, 2022:

- April 30, 2022 from 12:00PM – 4:00PM (**Hansel and Gretel The Musical, Ages 5-9**)
- May 1, 2022 from 12:00PM – 4:00PM (**Legally Blonde Jr, Ages 10-17**)

Please attend the correct day for auditions. Mr. Malcolm guarantees everyone who signs up will have a named, meaningful role in the production with at least 5 lines in the performance! :)

The performances will be on Saturday, June 4th and Sunday, June 5th. Each child will perform not only once, but multiple times! "Hansel and Gretel, The Musical" will perform at **10:00AM Saturday and Sunday**. "Legally Blonde Jr." will perform at **1:00PM and 4PM on Saturday and Sunday**. Tickets will all be general admission seating. Tickets will be sold on a first-come, first-served basis. Ticket sales may be limited by the state of NJ department of health guidelines at the time of the performance. The theatre reserves the rights to cancel any performances for health or safety reasons.

Payment to Mr. Malcolm's Spring Musical is completely non-refundable for any reason whatsoever. If the state of New Jersey allows theatres to remain open with limited capacity, social distancing, and CDC guidelines and restrictions, this activity will go on as scheduled. There is a limited number of applications we are accepting. We will accept them on a first-come, first-served basis.

NOTE: Safety protocols will be adhered to. NJ State Department of Health and CDC Guidelines will be in effect for rehearsals and performances. Please do not bring your child to rehearsal if he/she is ill. Children who have a fever or are taking any medication for an illness should not attend rehearsal.
